The validated data is then updated in the backend system to

ensure consistent records and to prevent duplicate effort.

Additionally, having a workflowbased billing process helps to enforce compliance with any financial rules the firm has implemented, such as an approval procedure for write-downs above a certain threshold.

Firms can manage the finance department's workload more efficiently, whether the distribution of proformas takes place in individual offices or from a centralized billing department. Senior-level billers can focus on complex invoices, while junior-level billers can deal with the high-volume, but low-change invoices.






#### Wilson Proforma Tracker Workflow
